## Collaboration and the FCIA Glossary

The Glossary is a thought-leadership tool for the fine chocolate ecosystem, and a space in which to develop a "common language" for fine chocolate.

The Glossary invites dialogue around fine chocolate terms, and establishes a set of meanings that we can all reference and share. While we hope that completed Glossary entries will spark conversation, we encourage collaboration and discussion during the entry-writing process too. We reach out to pairs and sometimes groups of individuals so that even one definition of a term can incorporate many voices.

# Step 3: Start writing the definition

## Step 5: Related Media

## Step 6: Get ready to publish!

An overview of the form is attached. Please feel free to go through all of the questions with your coauthor(s) beforehand to make sure that you can fill out the form as smoothly as possible.
